The Legacy of the Special Transit Name



Special Transit

During its first year of service 33 years ago, the tiny organization called Special Transit was located in two rooms in the old County Butler building on Pearl Street in Boulder, where the Kinkos/FedEx store is now located. When the roof blew off, the handful of part-time office employees and drivers had to relocate. Another temporary location was found, and there the vehicle maintenance program began in the dirt driveway outside, with one little coat closet to store tires.

What a long way we’ve come.

This organization was born in a time of inspiration and dreams. The visionary advocates who worked diligently to found Special Transit surely had a belief in an inclusive community for all, regardless of age or disability. And by manifesting their vision, others would be enabled to achieve their own dreams.

That early aspiration had a profound influence on the organization. Our beliefs and values arose from that hope, as well as the way we provide service — the kindness, the care, and the willingness to change to meet community needs. While these principles were born under the name of Special Transit, all remain under the umbrella of our new name, Via.

What has been left behind is just a name. What continues are the dreams, beliefs and values the organization was founded upon and that will be stewarded throughout the life of the organization.

A rider recently visited us, a gentleman who has been using our services for every one of our 33 years. While he completely understood all the reasons for the organizational name change, his closing comment was “You will always be *special* transit to me.” That’s a promise.



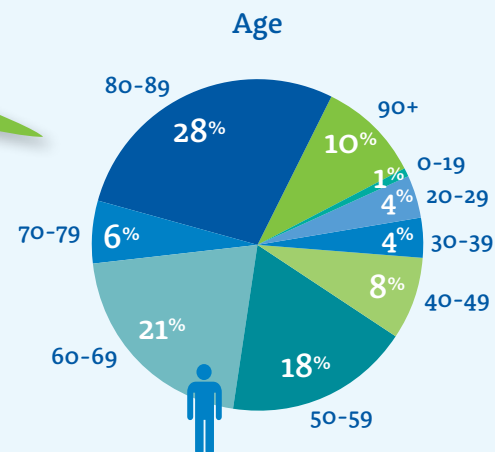
Income

To meet the Elder Economic Security Index in Boulder County...

- ♦ **\$18,288** is required annually for one older adult with no mortgage
- ♦ **\$28,572** is required annually for an elder couple with no mortgage
- ♦ **\$23,856** is required annually for one older adult renting a one bedroom
- ♦ **\$34,140** is required annually for an elder couple renting a one bedroom
- ♦ If an older adult is in poor health, **\$2,376** in annual increased income is needed
- ♦ If an older adult is in poor health and requires home- and community-based long-term care, annual income increases required range from **\$7,920** to **\$36,768**, depending on hours/week of care needed.
- ♦ The Boulder County Trends Report states **6%** of Boulder County's older adults live below federal poverty levels.

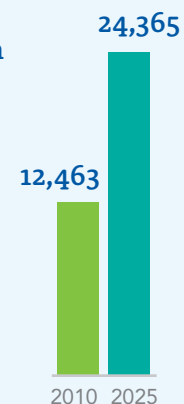
About our clients

- 57%** do not have the minimum income to meet The Elder Economic Security Index for Boulder County



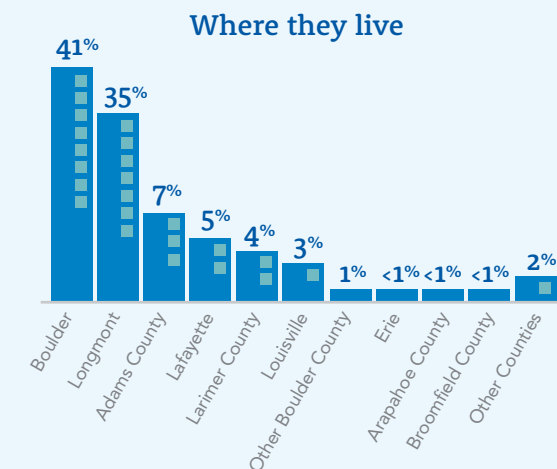
Population in service area

According to the 2010 Census, the population of older adults and people with disabilities in Via's service area is expected to grow 95% between 2010 and 2025.

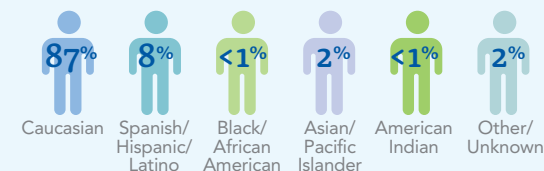


Disability Status

Accomplishments

- ♦ **January 28:** Ribbon Cutting and Building Dedication Ceremony for our New Facility for the 21st Century.
- ♦ **September 2:** Executive Director Lenna Kottke celebrated 20 years as leader of the organization.
- ♦ **September 28:** The Board of Directors unanimously voted to change the organization's name from Special Transit to Via Mobility Services.



Paratransit Program

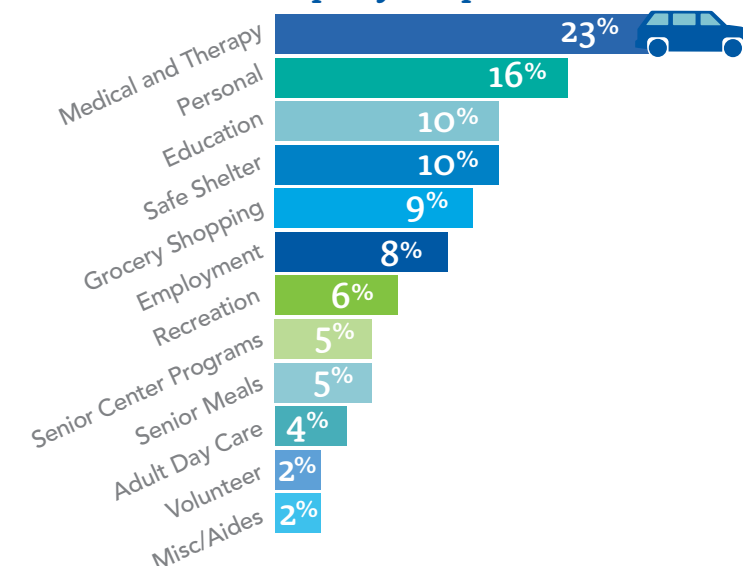
- 126,142 one-way trips were provided, the most in the history of the organization.

- 2,247 unduplicated individuals were served.
- Service to the Longmont community increased by 9%: 34,967 trips were provided.
- 12,293 trips were provided for individuals experiencing homelessness in order to secure safe shelter during the winter.
- 29,258 trips were provided for medical or therapy purposes.
- 17,065 trips were provided to ensure access to food and nutrition programs.
- 105,962 trips were provided in Boulder County, a two percent increase over 2010, and 1,946 residents were served.
- The average cost per paratransit trip was \$29.27.
- The volunteer driver collaboration with American Red Cross provided 2,194 trips.
- The Medical Mobility volunteer driver collaboration with Boulder County CareConnect provided 3,609 trips. The volunteer driver provides round trip transportation and stays with the rider through the health care appointment or procedure.
- 576,301 miles were traveled and 57,123 service hours were provided.

IMPACT

The 2011 Program Outcome Measurement Evaluation proved that 98% of riders agreed or strongly agreed our service helps them to be more self-sufficient and 97% agreed or strongly agreed we help them to be more independent.

Travel Training Program

- 59 individuals were served in the comprehensive one-on-one mobility assessment and travel training program.
- Ten community presentations were conducted on disability awareness and community transportation options; 264 attendees participated.
- Five Train the Trainer seminars were conducted with 26 participants.

IMPACT

The year-end Program Outcomes Measurement Evaluation showed that 50% of successful trainees agreed or strongly agreed that they felt more independent and had more confidence in their ability to get to where they needed to go as a result of the travel training. Successful trainees used public transit for an average of 17 trips per month.



Mobility Options and Individual Travel Planning

Acting as a travel navigator, the mobility specialist provides information and referral on a wide range of travel options, and individual travel plans are developed.

- The mobility specialist contacted 720 out of 1,009 newly registered clients.
- 501 had individual travel plans (ITP) developed.
- 255 individuals received ITP’s who did not become riders or trainees.

IMPACT

Year-end evaluations indicated that more than 39% were complying with their ITP.

13,826 trips were taken on public transit by individuals who had successfully completed the travel training program or complied with their ITP.

Safety

- The safety of our passengers, drivers and the public continues to be our highest priority.
- Drivers in the four divisions drove almost 3.2 million miles and completed the year averaging 0.75 accidents per 100,000 miles driven.
 - 33 drivers received Driver Safety Awards for maintaining a safe driving record for five to 10 years.
 - Five drivers received Driver Safety Awards for maintaining a safe driving record for 10 years.

OUR STANDARD

Definition of an accident: Any time a vehicle comes in contact with anything other than the tires touching the ground resulting in property damage or injuries of any amount.

Significant Organizational Achievements

- ♦ A total of 2,559 unduplicated individuals were served in the paratransit, travel training and mobility options programs and a total of 139,968 trips were provided or enabled.
- ♦ The organization moved into its new facility on January 10, 2011.
- ♦ Special Transit changed its name to Via.
- ♦ An unsolicited, windfall gift of \$383,000 was received from the Margaret Cargill Foundation.
- ♦ The HOP, Call-n-Ride and Access-a-Ride contract services provided 1,121,065 passenger trips.
- ♦ The financial year ended with a four percent margin of operating revenue over expenses.



Social Enterprise

Social enterprise in the nonprofit sector may be defined as “improving the effectiveness and sustainability of the organization by employing earned income contracts to achieve social objectives.”

As a nonprofit organization, Via ensures that all profits from the three earned income contracts are reinvested to enhance our mission services, to nurture the well-being of our organization, to reinforce our commitment to the communities we serve and to make our organization’s vision a reality.



The HOP

Total Passenger Trips 879,433

The HOP is the heart of Boulder’s Community Transit Network. The HOP is a high frequency circulator shuttle connecting the primary retail, social and educational centers in the city of Boulder, including the University of Colorado. The HOP is a fully funded contract with the City of Boulder, CU-Boulder and RTD.



Access-a-Ride

Access-a-Ride

Total Passenger Trips 103,140

Access-a-Ride is an on-demand paratransit program mandated by the Americans with Disabilities Act (ADA) and is provided throughout RTD’s (Regional Transportation District) fixed route service area. Riders on Access-a-Ride must be certified as having a disability that prohibits them from using the fixed route system. As the regional public transit provider, RTD is legally responsible to fund and ensure this service is available to eligible individuals.



Call-n-Ride

Call-n-Ride

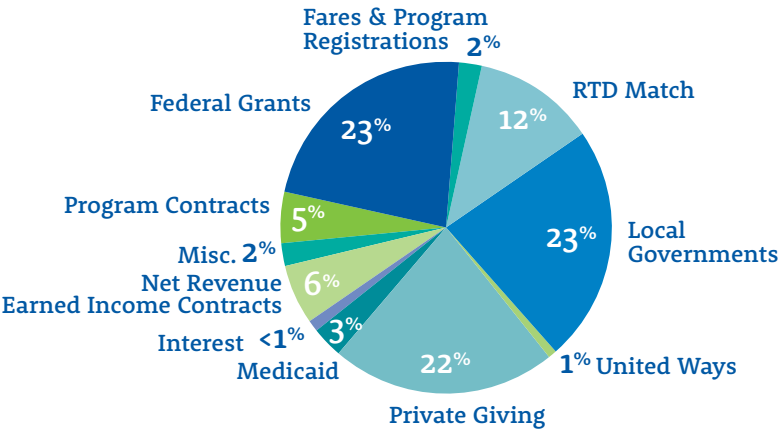
Total Passenger Trips 138,492

Call-n-Ride is a hybrid, demand-response service established to serve residents living in specific communities where fixed routes are generally not cost effective. Designed to connect people to the RTD park-n-Rides during peak hours, the service is open to anyone living or working within the defined geographic area for general transportation purposes. This is a fully funded contract with RTD.

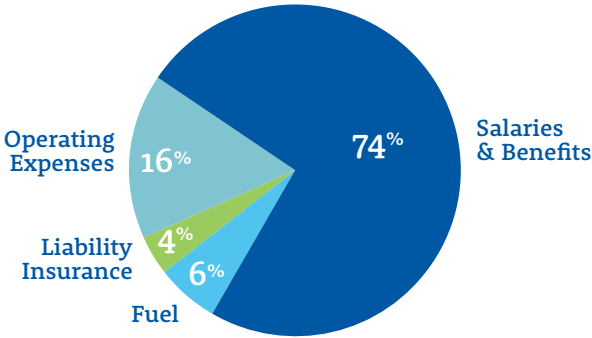

2011 Financial Highlights

Restricted Stock Award

During 2009, Special Transit received a gift of restricted shares of stock in a privately held company from the Margaret Cargill Foundation. The Foundation held the stock on our behalf and in 2011 exchanged the shares for stock in a publicly traded company and subsequently liquidated the acquired shares, providing a cash gift of approximately \$383,600, with the proceeds restricted to use for care of the elderly. The proceeds were recorded as unrestricted fundraising revenue during 2011, and approximately \$200,000 of the proceeds were utilized for support of mission services during 2011, with the balance remaining to support future program costs.

Capital Campaign Completion

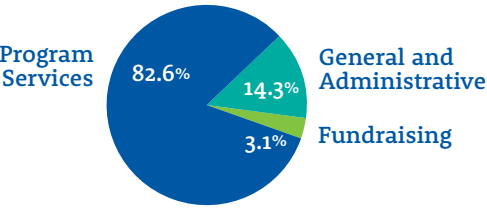
During 2008, Special Transit initiated a capital campaign to raise funds to be used toward the construction of its new headquarters and maintenance facility. Total funded costs toward construction of the facility were approximately \$11,240,000. The capital campaign was effectively closed during 2011 upon the completion and move into the new facility.

Change in Net Assets

Net assets released from restrictions for the year ended 12/31/2011 represents funds released related to remaining construction costs incurred for the new facility as well as federal funds related to capital purchases of equipment.

Net Income

The Board of Directors directs staff to budget and manage for a three percent margin of organizational revenue over expenses. In 2011, this margin was approximately four percent. Income over expenses is used to maintain required operating, facilities and vehicle reserves. The Board may also determine an allocation to any of three endowments held by the organization.
