Via provides traditional paratransit service in eight counties. This service is a wheelchair-accessible, door-through-door, driver-assisted, demand-response service, serving older adults and individuals with disabilities.

Via Paratransit provided over 135,000 trips and served more than 3,500 unduplicated individuals in 2021.

Via also provides a travel training program to teach older adults and people with disabilities how to safely and confidently use public transportation to expand their independent travel options. A total of 109 people were served in 2021 in the comprehensive individual travel training program and evaluations indicate that successful trainees take an average of 15 trips per month on public transit.
